



Appendix D: Related Plans and Studies

Town of Fenner Comprehensive Plan, 2009

Sponsor: The Town of Fenner

Adoption Year: 2009

Fenner adopted its first comprehensive plan in 2009 and was created by a consultant. To better guide land use and zoning decisions, the town board decided it was in the Town's best interest to create Fenner's first comprehensive plan. The comprehensive plan was divided into three parts: current land use and trends, current land use issues, and general recommendations.

- The number of farms and farmland acreage has decreased in Madison County since the early 2000s.
- During the early 2000s, 16 dairy farmers in Fenner were shipping milk, which was more than any
 other town in the County. However, the dairy sector declined during this time due to low milk
 prices and increasing input costs.
- During this time period, the Amish started moving to Fenner from Ohio and Pennsylvania to begin farming.
- Since 1998, limited residential development has occurred on agricultural land.
- Limited non-agricultural businesses reside in the Town.

Identified issues and questions:

- Concern for preserving farmland and agricultural uses in a weak farm economy.
- Do present zoning regulations inhibit promoting alternative and supplemental agricultural enterprises to support the rural economy?
- Do present zoning regulations adequately anticipate future alternative energy initiatives, including wind turbines, commercial and private, solar, small hydro projects, and other innovative technologies?
- Do present zoning regulations adequately anticipate future gas well development that protects the environment and landscape without unduly restricting landowners?
- Do the current A zone/ B zone regulations adequately determine where best to locate small businesses that do not impact the Town's rural character?
- Are current regulations for mobile homes and manufactured homes adequate to protect the overall interests of the Town without unduly restricting the availability of affordable housing?
- Are current policies and procedures adequate for enforcing existing regulations for buildings, junkyards, and property maintenance?

Recommendations:

- Review the Town's current land use laws to ensure that the regulations encourage the preservation of farmland and agricultural uses.
- Examine the current definitions of farms and agricultural uses to determine if they adequately encompass the innovative types of agricultural activities the Town is encouraging.
- Consider revising current zoning provisions to promote on-farm alternatives and supplemental agricultural business enterprises to support the rural economy.

- Consider zoning provisions to promote alternative energy initiatives, including commercial and private wind turbines, solar, small hydro projects, and other innovative technologies.
- Consider planning and zoning provisions for future gas well developments that protect the environment and landscape without unduly restricting landowners.
- Review current A zone/B zone regulations to determine whether the current regulations serve
 the Town's best interests, and whether it is advisable to continue to limit business uses to Zone
 A.
- Review regulations for mobile homes and manufactured homes to determine whether current regulations should be modified without unduly restricting the availability of affordable housing within the Town.
- Review procedures for enforcement of existing regulations for buildings, junkyards, and property
 maintenance to determine whether changes to promote more effective enforcement and clean
 up are warranted.

Madison County Agriculture and Farmland Protection Plan

Sponsor: Madison County, New York

Year Adopted: 2019

The purpose of the Agriculture and Farmland Protection Plan is to protect Madison County's agricultural economy and productivity. Current trends threatening the County's overall landscape are changing economic markets, loss of farms, loss of farmland to competing uses, and climate change.

The County conducted a land use assessment to determine priority land for protection. The variables for this assessment focused on development threats, the size of parcels, zoning laws, land trust protection, soil quality, scenic value, water resources, connectivity, and active agricultural use.

The plan identified that Fenner and its respective land should be of high priority for protection. The document states, "Perhaps lower development pressure than some areas in the County, this area has a significant agricultural presence, low existing protection, and a supply of large parcels that may be conducive to conversion to uses such as solar farms. Good soils are present as well. Unfortunately, only a portion of this area is covered by the Cazenovia Preservation Foundation."

Based on the assessment, six priority goals and respective actions were identified for the County and towns. The six main goals are:

- 1) Attract and enable new farmers to continue agricultural productivity in Madison County.
- 2) Support and enhance opportunities for the local agricultural economy.
- 3) Update and streamline local land use regulations across Madison County.
- 4) Protect land, water, and other resources that enable agriculture to remain prevalent in Madison County.
- 5) Foster direct positive relationships between farm and non-farm communities.
- 6) Work to prepare local farmers for climate change impacts and reduce local agriculture-based emissions.
