RESOLUTION NO 2020 – 10

A RESOLUTION ADOPTING THE TOWN OF FENNER
HIGHWAY SUPERINTENDENT HEALTH INSURANCE WAIVER POLICY
OF THE BOARD OF TRUSTEES
OF THE TOWN OF FENNER

WHEREAS, the Town of Fenner Town Board offers health insurance benefits to its
elected highway superintendent; and

WHEREAS, the Town Board deems it in the best interest of the Town to offer a financial
incentive to the elected superintendent of highways if he or she declines the Town's health
insurance benefit.

NOW THEREFORE, IT IS HEREBY RESOLVED by the Town Board of the Town of
Fenner that the elected Town Highway Superintendent may opt out of participation in the Town's

group health insurance plan by giving written notice of such intention to the Town Supervisor. Any such request shall be effective as of the end of the month in which such notice is given, provided that notice has been received by the Supervisor by the 15th of the month, otherwise the opt out shall be deemed effective as of the end of the following month.

AND IT IS HEREBY FURTHER RESOLVED that if the elected Town Highway Superintendent completely opts out of the Town's group health insurance program, he or she shall be paid a non-wage stipend in the amount of up to \$3,000 per year, as determined at the time by the Town Board, which shall be paid to the Highway Superintendent in quarterly installments.
